RECITALS

- A. McWhinney Holding Company, LLLP, a Colorado limited liability limited partnership is the Declarant under that certain Second Restated and Amended Master Declaration of Covenants, Conditions and Restrictions for Centerra recorded on August 18, 2004 at Reception Number 2004-0081192 in the offices of the Clerk and Recorder of Larimer County, Colorado, as it has been amended and supplemented from time to time ("Master Declaration").
- B. The Master Declaration contemplates the recording of supplemental declarations from time to time for the purpose of annexing real property from the provisions of the Master Declaration.
- C. This Supplemental Declaration is a "Supplemental Declaration" referred to in the Master Declaration.
- D. Centerra Ground Leases, LLC, a Colorado limited liability company ("**CGL**") is the owner of the real property described on <u>Exhibit A</u> attached hereto and incorporated herein by this reference (hereafter the "**Annexed Property**").
- E. Declarant desires to subject the Annexed Property to the provisions of the Master Declaration as supplemented and amended hereby.

ARTICLE 5 Miscellaneous

- 5.1 <u>Binding Effect</u>. This Supplemental Declaration and all covenants, conditions, restrictions and other provisions hereof shall run with and be appurtenant to the land affected, and all such terms shall inure to the benefit of and be binding upon the Property.
- 5.2 <u>Counterparts</u>. This Supplemental Declaration may be executed in several counterparts, each of which shall be deemed an original.
- 5.3 <u>Governing Law</u>. This Supplemental Declaration shall be construed and interpreted in accordance with the laws of the State of Colorado applicable to contracts made in and to be performed wholly within Colorado.
