FIRST: The name of the Corporation is ROCKY MOUNTAIN VILLAGE MASTER ASSOCIATION, INC. *NCGS*

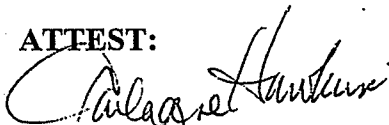

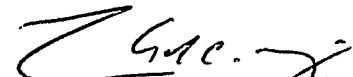
THIRD: The name of the Corporation is amended and changed to CENTERRA COMMERCIAL OWNERS ASSOCIATION, INC.
