The District is funded via a mill levy which is assessed to each property owner as a part of their annual property taxes. The current residential mill levy is 77.730 mills, the maximum allowed for this District. The current overall mill levy on properties within District No. 2 is 157.241.

Sample Calculation:

\$500,000 Actual Value X 7.15% assessment rate = \$35,750. \$35,750 assessed value/divided by 1,000 (mill levy applies to every \$1,000 of value) x 77.730 = \$2,778.85 in annual property taxes paid to the District. The overall payment for all taxing authorities would be 5,561.95.

4. How is the District governed and managed?

The District is governed by a five-member Board of Directors and meets quarterly beginning in February. Meeting notices are posted on the District's website at www.lakes-metro-district.com at least 24 hours prior to the meeting.

Sample Calculation:

\$500,000 Actual Value X 7.15% assessment rate = \$35,750. \$35,750 assessed value/divided by 1,000 (mill levy applies to every \$1,000 of value) x 74.320 = \$2,656.94 in annual property taxes paid to the District. The overall payment for all taxing authorities would be 5,499.46.

4. How is the District governed and managed?

The District is governed by a five-member Board of Directors and meets bi-monthly beginning in February. Meeting notices are posted on the District's website at www.lakes-metro-district.com at least 24 hours prior to the meeting.
